### A. Application Form

Application for Admission to Undergraduate (UG) Programmes {B.V.Sc. & A.H., B.Sc.(Hons.) Agriculture and B.Tech. (Food Technology)}, Masters' Programmes {M.Sc. Agriculture, M.V.Sc., M.Sc. Basic Sciences and M.Sc. Community Science} and Doctoral Programmes (Ph.D. Agriculture, Ph.D. Veterinary & Animal Sciences, Ph.D. Community Science and Ph.D. Basic Sciences) of the University

#### (i) All candidates except NRIs/OCIs/Foreign Nationals

The candidates are advised to go through the instructions thoroughly on the University website <http://hillagric.ac.in> before filling up the online application form for the respective programme. The candidates applying for admission to the programme(s) of this University will have to fill the respective online application form at the University Website <http://hillagric.ac.in> alongwith uploading of all the self-attested photocopies of requisite certificate/ documents relating to admission as mentioned in the Counseling proforma (Annexure IX) and deposition of requisite application fee online through payment Gateway by the last date of receipt of online application forms.

#### **Important instructions for the candidates for applying to the degree programmes**

- i. For admission to Undergraduate Programmes {B.V.Sc. & A.H./B.Sc. (Hons.) Agriculture/ B.Tech.(Food Technology)}, the candidates shall have to furnish their particulars including Roll No., score and rank of NEET(UG)-2025/ CUET(UG)-2025 accompanied with uploading of self-attested photocopies of relevant certificates/documents and Score Card relating to admissions alongwith the online application form by the stipulated date. For Masters' Programmes {M.V.Sc./M.Sc. Ag./ M.Sc. Basic Sciences/ M.Sc. Community Science} and Doctoral Programmes {Ph.D. Veterinary & Animal Sciences/ Ph.D. Agriculture/ Ph.D. Community Science/ Ph.D. Basic Sciences}, the candidates shall first of all have to furnish their particulars accompanied with uploading of self-attested photocopies of relevant certificates/documents relating to admissions alongwith the online application form by the stipulated date EXCEPT Roll No., score and rank of ICAR AIEEA (PG)-2025/ ICAR AICE-JRF/SRF (Ph.D.)-2025. The candidates for Masters' programme shall have to mention the Major Subject Groups of ICAR AIEEA (PG)-2025 in which he/ she is willing to be considered for admission at this University. As soon as the ICAR AIEEA (PG)-2025/ICAR AICE-JRF/SRF (Ph.D.)-2025 result is declared, the University will issue a notification on its website for the candidates to Masters' and Doctoral programmes to complete the online application process by providing the information with respect to 1) Roll Number issued by the National Testing Agency, 2) Total Marks obtained, ALL INDIA RANK/OVERALL RANK obtained by the candidate in ICAR AIEEA (PG)-2025/ ICAR AICE-JRF/SRF (Ph.D.)-2025 and by uploading the SCORE CARD of respective Entrance Test. All the candidates must have to complete the said process within the stipulated time failing which his/her right for admission to the programme(s) through Counseling-cum-Registration and Admission-I and II shall stand forfeited and no correspondence in this regard shall be made. However, such candidates can participate/take part in the final round of counseling/mop up round for admission to the respective programme. The candidates must ensure that he/she has furnished the correct 1) Roll Number issued by the National Testing Agency, 2) Total Marks obtained, ALL INDIA RANK/OVERALL RANK obtained in NEET (UG)-2025 / CUET (UG)-2025/ ICAR AIEEA (PG)- 2025/ ICAR AICE-JRF/SRF (Ph.D.)-2025 in his/her online application form within the stipulated period failing which his/her candidature for admission will not be considered and the individual will be solely responsible for it. At this time, no candidate shall be allowed to rectify/add/modify their information/particulars already filled in their online application form.

Note:

- i) The candidates applying to Undergraduate programmes shall have also to upload the self-attested photocopies of original marks sheet of the qualifying examination alongwith other relevant certificates/documents including NEET (UG)-2025/CUET(UG)-2025 Score Card relating to admission alongwith the application forms.

- ii) For admissions to Masters' and Doctoral programmes, the candidates appearing in the qualifying examination can also apply provided they will have to produce original marks sheet of the qualifying examination including PDC/ Proof of completion of qualifying degree duly countersigned by the Registrar at the time of Counseling-cum-Registration & Admission-I/II, as the case may be, failing which their candidature will not be considered.
- iii) The candidate shall have to mention his/her category particulars correctly while submitting online application form of this University. His/her candidature will only be considered against the specific category for admission by the University as he/she has applied for the said category at the time of filling online application form.
- iv) For admissions against SFS seats, the candidates shall have to apply in the online application form along with requisite APPLICATION fee + additional fee for self-financing seat(s) at the time of filling online application form for the programme failing which no option/request shall be entertained subsequently or at any later stage. **If a candidate does not opt for Self-Financing seat at the time of filling online application form, his/her candidature for self-financing seat will not be considered later on even in the Final round of counseling/mop-up round.**
- v) Non-H.P. Bonafide candidates can only apply for self-financing category by depositing requisite APPLICATION fee + additional fee for self-financing seat as specified in "A" as Application Fee. In case, due to non-availability of HP Bonafide candidates, their candidature can be considered against the vacant seat(s) of HP Bonafide category, if any, at the time of final round of counseling/mop-up round. In such cases, the candidates shall have to attend the final round of counseling/mop-up round.
- vi) The charges for application fee to be deposited through online payment gateway mode, if any, are to be borne by the candidate himself/herself.

## INTRODUCTION

Himachal Pradesh Krishi Vishvavidyalaya (HPKV), Palampur was established by the then visionary Chief Minister of Himachal Pradesh, Hon'ble Shri Shanta Kumar Ji on 1<sup>st</sup> November, 1978, with Solan as its second campus. It was rechristened as Chaudhary Sarwan Kumar Himachal Pradesh Krishi Vishvavidyalaya (CSKHPKV) on June, 2001. On December 1, 1985 the Solan campus was carved out from the State Agricultural University and renamed as Dr. Yashwant Singh Parmar University of Horticulture and Forestry, Solan. Earlier the agricultural education in Himachal Pradesh was imparted by two Colleges of Agriculture- one at Palampur and the other at Solan which were the part of the then Agricultural Complex functioning under Himachal Pradesh University, Shimla. The College of Agriculture, Palampur was established in 1966 under Punjab Agricultural University, Ludhiana and the College of Agriculture, Solan in 1964 under Panjab University, Chandigarh. With the trifurcation of the state of Punjab in 1970 and establishment of Himachal Pradesh University (HPU), Shimla; teaching, research and extension education in agriculture came under the umbrella of the Agricultural Complex with its headquarter at Palampur under the HPU. The University has been mandated for imparting quality education in Agriculture, Veterinary & Animal Sciences, Community Science, Basic Sciences and allied disciplines of learning, undertaking need-based research for the hill and mountain farmers of the State and further extension of such technologies to the stakeholders with the following objectives:

- i. Imparting education in agriculture and other allied branches of learning and scholarship which University may find necessary to include.
- ii. Furthering the advancement of learning and persuasion of research both basic and applied.
- iii. Undertaking extension of such sciences, especially to the rural people of the State.
- iv. Such other purposes as the University may determine from time to time.

To achieve its mandates and objectives, there are four constituent colleges (Agriculture, Veterinary & Animal Science, Basic Sciences and Community Science), a Directorate of Research and a Directorate of Extension Education, Students' Welfare Organization, Library, ICT Cell etc. These Colleges offer 7 Bachelor, 27 Masters and 16 Doctoral Degree Programmes. The University is marching by leaps and bounds towards excellence which can be judged from the fact that the University has been ranked at 14<sup>th</sup> position at All India Level in the ICAR's ranking of farm Universities.

### Building Partnership

The University maintains intra-institutional linkages with various departments of the constituent Colleges and its Regional Research Stations and Extension Centres. In order to develop quality education and research collaborations, the University has entered into Memorandum of Understanding (MOU) with Regional, National and International Institutions in the priority/thrust areas to expand its strategic partnership. The University has MOUs with various prestigious institutions.

### Location

The campus of the University is located at a distance of 3 km from the Palampur bus stand along the Pathankot-Mandi National Highway (NH-154) at an elevation of about 1250 meter above mean sea level. It is also linked with narrow gauge railway and the nearest station is Palampur (Himachal Pradesh), which is about 5 km from the University Campus. The Civil Airport at Dharamshala (Gaggal) is about 50 km from the Campus. The 600 hectare farm of the University including 198 hectare at out campus dotted with imposing beautiful buildings against the backdrop of panoramic majestic snow-clad Dhauladhar range makes it picturesque.

### Constituent Colleges

The University has following four colleges:

#### 1. College of Agriculture

The College of Agriculture, Palampur was initially conceived as a Junior College of Agriculture cater to the educational needs of far-flung hilly areas of the then Punjab. It was formally inaugurated by Late Dr. P.N. Thapar, ICS (Retd.), the first Vice-Chancellor of Punjab Agricultural University (PAU) on August 1, 1966.

The then Deputy Prime Minister of India, Late Shri Morarji Ranchhodji Desai laid the foundation stone of the college building on May 23, 1968. With the reorganization of the Punjab on November 1, 1966, the college became part of the territorial jurisdiction of Himachal Pradesh. Nevertheless, it remained a part of PAU till July 21, 1970. With the inception of Himachal Pradesh University on July 22, 1970, the college became a part of the Agricultural Complex under the aegis of Himachal Pradesh University which comprised agricultural colleges of Palampur and Solan along with research stations located at different places in Himachal Pradesh.

The college attained the status of a postgraduate institution in 1971 and postgraduate classes in the disciplines of Agronomy, Plant Breeding & Genetics, Soil Science & Agricultural Chemistry were transferred from Solan to Palampur. The doctoral programme in these disciplines was initiated in 1974. Postgraduate classes in Animal Sciences and Agricultural Economics were started in 1976 and 1978, respectively. The degree courses in Basic Science were started in 1971 and continued till date.

It was an historic event when the College of Agriculture, Palampur served as the nucleus for Himachal Pradesh Krishi Vishwavidyalaya which came into existence by an Act of the H.P. Vidhan Sabha; the HPKV Act, 1978 and was inaugurated on November 1, 1978 by the then President of India, Late Shri Neelam Sanjiva Reddy.

At present, the College of Agriculture has 13 departments viz. Agricultural Biotechnology; Agricultural Engineering; Agricultural Economics, Extension Education & Rural Sociology; Agronomy; Genetics & Plant Breeding; Entomology; Horticulture and Agroforestry; Organic Agriculture & Natural Farming; Plant Pathology; Seed Science & Technology; Soil Science; Tea Husbandry & Technology and Vegetable Science & Floriculture. The College is offering B.Sc. (Hons.) Agriculture programme, and Master's programme in 9 disciplines and Doctoral programme in 7 disciplines. At present, 538 UG and 324 Masters' and 159 Ph.D. students are on rolls of the College of Agriculture. The college is pioneer in hill and mountainous agriculture and took lead in creating first independent Department of Organic Agriculture and Natural Farming in the country. The college has adopted 6<sup>th</sup> Deans' Committee curricula and implemented National Education Policy 2020 from academic session 2024-25 for its undergraduate programme. In order to expose students to generate entrepreneurship and self-employment avenues, the experiential learning modules such as Protected Cultivation, Commercial Vegetable Production, Mushroom Cultivation, Tea Husbandry & Technology, Beekeeping, Nursery Management, Seed Production & Technology and Organic Agriculture and Natural Farming have also been offered.

## **2. Dr. G.C. Negi College of Veterinary and Animal Sciences**

The College of Veterinary and Animal Sciences was established in 1986 to cater the specific needs of the Animal Husbandry sector of the state under the aegis of Himachal Pradesh Krishi Vishwavidyalaya. Earlier, it was felt that very little efforts have been made to promote livestock production and control of diseases, besides research and extension under Sub-Mountain, temperate and sub-temperate conditions of Himachal Pradesh. There was a general consensus that tremendous scope exists for livestock development including education research and extension besides conservation of natural germplasm of typical hill species like Yaks, Gaddi sheep, goats, hill cattle and a variety of wild species of fauna (animals and birds), which otherwise could not be better looked after by the veterinarians trained in other parts of the country. There was also a wide gap in livestock resources available in the State vis-à-vis the qualified human resources to provide efficient veterinary health cover. The HPKV constituted an expert committee in consultation with the Indian Council of Agricultural Research for assessing the establishment of a Veterinary institution. This committee, in its meeting on 19<sup>th</sup> December, 1985 at HPKV recommended the establishment of a Veterinary College at Palampur as a model Veterinary College for hilly regions of the country. Consequently, the College of Veterinary and Animal Sciences (COVAS) was established by the State Government in 1986 and it was duly accredited by the ICAR and approved by the Board of Management of the University with the six composite departments viz. Animal Production, Anatomy & Histology, Veterinary Physiology & Pharmacology, Veterinary Microbiology, Pathology & Parasitology, Veterinary Surgery & Gynaecology, and Veterinary Medicine. With the progressive development of teaching and research facilities and as per the recommendation of the Veterinary Council of India, minimum standards of veterinary education (MVSE, 2016), the following 18 departments have been created: Veterinary Anatomy; Veterinary Physiology & Biochemistry; Veterinary Pharmacology & Toxicology; Veterinary Parasitology; Veterinary Microbiology; Veterinary Pathology; Veterinary Public Health & Epidemiology; Animal Nutrition; Animal Breeding & Genetics; Livestock Production & Management; Veterinary Gynaecology & Obstetrics; Veterinary Surgery &

Radiology; Veterinary Medicine; Livestock Products Technology; Veterinary & Animal Husbandry Extension Education; Fisheries; Veterinary Clinical Complex and Livestock Farm Complex.

Initially the postgraduate programme was only in the Department of Animal Nutrition and Animal Breeding & Genetics disciplines. In the COVAS, the master's programme in Veterinary disciplines was started in 1992 and now it is being offered in 13 disciplines namely Animal Genetics and Breeding, Animal Nutrition, Animal Reproduction & Gynaecology, Veterinary Microbiology, Veterinary Pathology, Veterinary Surgery & Radiology, Veterinary Anatomy, Veterinary Biochemistry, Veterinary Medicine, Veterinary Parasitology, Veterinary Pharmacology, Veterinary Physiology and Veterinary Public Health. The doctoral programme is offered in seven disciplines viz. Animal Genetics & Breeding, Animal Nutrition, Animal Reproduction Gynaecology & Obstetrics, Veterinary Anatomy, Veterinary Microbiology, Veterinary Surgery & Radiology and Veterinary Medicine. The College is the only referral Veterinary hospital of the state.

### **3. College of Basic Sciences**

Basic Sciences serve as the foundation for all branches of scientific innovation and are the building blocks upon which the entire edifice of scientific progress stands. It holds a pivotal role in agricultural education and research owing to its significance in understanding basic principles and concepts that have laid the foundation of modern technologies in agriculture and allied sciences. The College of Basic Sciences was established in the year 1991 with the mandate to fulfil the need of quality education in basic sciences in the region and for catering to the needs of teaching and research in agricultural and allied sciences. The college offers four year undergraduate programme in two streams i.e. B.Sc. (Hons./Hons. with Research) Physical Sciences (Physics/Chemistry/Mathematics) and B.Sc.(Hons./Hons. with Research) Life Sciences (Botany/Zoology/Chemistry) with multiple entry and exit options. Additionally, the college is also engaged in teaching common courses pertaining to agricultural and allied programmes at UG/PG level to all the constituent Colleges of the University. The College has four departments and one centre viz., Biology and Environmental Sciences, Chemistry and Biochemistry, Microbiology, Physical Sciences and Languages and Centre for Geo-Informatics Research and Training. The College is equipped with state of the art 10 Laboratories [Physics, Chemistry, Botany, Zoology, Computer, Biochemistry, Microbiology (UG & PG), Environmental Sciences and GIS & Remote Sensing]. The College of Basic Sciences is the first in the State of Himachal Pradesh to adopt and implement the guidelines of National Education Policy - 2020 for its undergraduate programmes in basic sciences. Currently M.Sc. and Ph.D. programme is being offered in the discipline of Microbiology. M.Sc. programmes (Biochemistry, Environmental Sciences, Biology and Plant Physiology) and Ph.D. programme (Biochemistry) are currently held in abeyance. The faculty of College of Basic Sciences is striving hard to fulfill the mandate through quality education alongwith research and extension supportin the University maintaining high standards and to generate quality human resources to benefit the rural masses of the State.

### **4. College of Community Science**

The College of Community Science, earlier Home Science, was established in May, 1991 with the mission to empower individual, family and community for effective role performance and management of resources to improve the quality of life. It primarily emerged out of the much felt need for a comprehensive training to the students in the context of changes in the socio-economic environment as well as changes in the family system and functions. Community Science was conceptualized basically as an interdisciplinary applied area of study built upon the basic and social scientific knowledge. The college offers Bachelor's degree programme in B.Sc. (Hons.) Community Science, B. Tech. (Food Technology) and B.Sc. (Hospitality and Hotel Administration). There are five major components of B.Tech. (Food Technology) viz. Food Technology, Food Engineering, Food Quality Assurance, Food Business Management and Food Plant Operations. The master's programme is offered in the disciplines of Food & Nutrition, Human Development & Family Studies, Resource Management & Consumer Science and Apparel & Textile Science. The doctoral programme is offered inthe discipline of Food and Nutrition. Experiential Learning Units are operational for the undergraduate students to promote their entrepreneurial skills, confidence building and to prepare them for self-employment in the emerging areas. Recently the curriculum has been modified to inculcate entrepreneurial skills for self-employment and to increase students' competence to work in Government/ Private Sector. The College is committed to excellence, innovation and effectiveness in teaching, research and extension through qualified and competent faculty and well equipped laboratories/ infrastructure.



**Advisory System:**

The University ensures attention to individual student through its advisory system. The Dean of College concerned assigns each undergraduate student to a teacher of the college who acts as the 'Advisor' to the student in all academic matters and also nominates a teacher of the college to act as 'Tutor' of an undergraduate class who would coordinate with all the Advisors of that class for proper supervision and registration of students of that class. The advisory system has been strengthened and has developed as 1+0 non-credit course. At postgraduate level, an advisory committee consisting of 3-5 teachers with one Major Advisor is appointed for each student. The major advisor also maintains a close contact with parents/guardians of his/her advisees.

**Directorate of Research**

The Directorate of Research coordinates research in the field of agriculture, veterinary and animal sciences, community science and basic sciences. Priority is given to the location specific, need based and problem oriented research with multidisciplinary approach at the main campus, Palampur and its various satellite stations viz. Hill Agricultural Research and Extension Centre, Bajaura and Dhaulakuan & Highland Agricultural Research and Extension Centre Kukumseri and 10 sub stations i.e. Rice and Wheat Research Centre Malan; Bee Research Station, Nagrota Bagwan; Research Sub Station Kangra, Salooni, Akrot, Berthin, Sundernagar, Sangla, Leo & Lari situated at different locations representing different agro-climatic zones of the State. Research activities in the University are mainly carried out through All India Coordinated Research Projects and various adhoc research projects financed by different outside funding agencies. There are various research projects on different thematic areas of agriculture and allied sectors including AICRPs are in operation. The University has developed and released more than 150 improved varieties of different crops. The University produces around 800 and 1000 quintal breeder and foundation seed respectively of cereals, pulses, oilseeds, vegetables and fodder crops seed. It is supplied to the State Department of Agriculture for further multiplication and making it available to the farming community. To enhance crop and animal productivity, the University has developed >100 farm technologies which have been recommended to the farmers in the areas of crop improvement, animal breeding, disease combating, natural resources management etc. The University is presently focusing its research activities on natural farming and a **Model "Zero Budget Natural Farming"** has been established in the University in an area of 25 acres. The University is pioneer in the country to establish an **Advanced Centre on Protected Agriculture and Natural Farming** with an outlay of Rs. 2266 lakhs from World Bank sponsored National Agricultural Higher Education Project of the ICAR. It initiated research for developing technologies for safe farm produce.

**Directorate of Extension Education**

The Directorate of Extension Education (DEE) provides extension services to the farming community of the state through various programmes and activities planned, coordinated and implemented at the headquarter as well as through its eight Krishi Vigyan Kendras (KVKs) located at Dhaulakuan (Sirmour), Bajaura (Kullu), Bara (Hamirpur), Una, Sundernagar (Mandi), Kangra, Kukumseri (L&S), Berthin (Bilaspur). Such programmes and activities include Trainings, Front line Demonstrations, Field days, Kisan Melas/ Kisan Goshthi, Crop Seminars, Exhibitions, Radio Talks, TV Telecast, Film Shows, Workshops etc. The directorate has close coordination and liaison with various line departments of government. The Directorate and its KVKs are equipped with experienced team of Scientists/ Extension Specialists with focus on dissemination of promising technologies emerging from various research outcomes in Agriculture, Animal Husbandry and food processing and value addition etc. of the University to the field functionaries and farmers. The Directorate is involved in the capacity building of the extension functionaries of departments of Agriculture, Horticulture and Animal Husbandry through trainings and workshops viz. model training courses, refresher courses and other such activities involving the stakeholders. Various projects are in operation for evaluation and demonstration of newly developed technologies at the directorate and KVK level for the upliftment of farmers. The directorate has entered into MOUs with institutions like ICAR, NABARD, SJVN, ATMA, etc. for technology transfer. The directorate and KVKs are involved in skill development trainings sponsored under Agricultural Skill Council of India to produce agri-entrepreneurs to establish agricultural related business enterprises. The Agricultural Technology Information Centre at the Directorate is involved in providing services to the farmers of the state by providing literature, improved seeds and planting material and other inputs including various R & D products and through

telephonic helpline by addressing various queries related to farming. Each KVK takes care of technology evaluation through on farm testing, demonstration, trainings of field functionaries and farmers under district level micro-situation. The feedback by the KVK scientists regarding the university technologies and other NARS (National Agricultural Research System) institutions help the university research system in designing new projects for further research and development in Agriculture and allied sciences.

#### **International Coordination Cell (ICC)**

To facilitate foreign/International students for admissions and their stay at CSKHPKV, Palampur, an International Coordination Cell having an Executive Committee, an Advisory Committee with Registrar as its Liaison Officer has been established.

#### **Students' Welfare Organization**

This organization is responsible for overall welfare of the students including hostel accommodation, personality development, counseling & placement, sports and co-curricular activities, NSS and NCC activities besides maintenance of discipline amongst the students. Every undergraduate male and female student is required to undergo compulsory NCC / NSS courses, during the first two years of his/her degree programme. **The university extends opportunity for female students to join NCC.** The office of the organization is housed in the Khel Parisar of the University.

**Hostel Facilities:** There are 10 students' hostels (housing 1130 students) comprising five for girls including an independent wing for international women students, four for boys and one for international men students. The accommodation for international students has attached washroom and kitchen for self-cooking. Each hostel is looked after by Wardens appointed from amongst the faculty. The hostel messes are run on co-operative basis and are being managed by the hostel residents on rotation, providing an opportunity to work in a team and learn management skills. The hostels are provided with internet facility, CCTV cameras, washing machines, newspapers, etc., besides television and facilities for indoor and outdoor games.

**Sports Facilities:** The University has a well-maintained playground with 400 meters standard six lane track and with facilities to play, football, hockey, cricket, besides a well-equipped gymnasium and indoor table tennis, basketball, volleyball and badminton courts.

**Human Resource Development and Placement Centre:** This centre has been established by the University under Students' Welfare Organization to provide guidance to students for pursuing higher education both within the country and abroad; to impart coaching for competitive examinations both for winning scholarship and employment; to assist the students in finding and exploring the employment by proper placement, in collaboration with other units of the university the Directorate of Extension Education, possibility for self-employment, entrepreneurship to the unemployed graduates through different programmes run by different agencies like through PM/CM startup and RKVY- RAFTAAR schemes of the Government.

#### **University Library**

The library of the University at Palampur campus is well equipped with all the relevant reading materials. It caters to the needs of the students, teachers, extension specialists and the staff of the University. The university has more than 1 lakh books, 965 e-books and 2428 digitized books on Himachal Pradesh. In addition to it, 5394 Master and Doctorate thesis have been uploaded on the library web site. Library provides online i.e. web based OPAC (On-line Public Access Catalogue), access to full text online journals through CeRA (Consortium for e-Resources in Agriculture), online CAB Abstracts, e-books, e-theses and other reading materials. Library is fully automated with RFID (Radio Frequency Identification Device) system integrated with KOHA Library Management System. The FAO has designated the University Library as "FAO Repository" therefore, it is entitled for FAO publications free of cost. Himachal Section of the Library is fully equipped with books on Himachal Pradesh and the books written by the authors of Himachal origin. All the books of Himachal Section are available in digital form also. The university library is equipped with anti-plagiarism software.

#### **Health Centre**

The University has its own health centre with two medical officers and para medical staff (staff nurses, pharmacist, laboratory technician, etc.) The hospital is equipped with the facilities like pharmacy counter, nursing care station and laboratory. In addition, medical facilities are also available at Vivekanand Medical Research Institute and Civil Hospital, Palampur. In the health centre, all the routine clinical tests are conducted under scientific condition. Medical fitness certificate and driving license certificate are provided to all the students, university and IHBT employees after complete checkup. In case of emergency, the patients are referred to Civil Hospital, Palampur, Dr. Rajendra Prasad Government Medical College, Tanda and Vivekanand Medical Research Institute, Palampur.

**Information and Communication Technology Cell**

The Information and Communication Technology Cell was established in September, 2020 under the office of Vice-Chancellor Secretariat to facilitate the use of information and communication technologies for the benefit of the students, farmers and researchers. ICT cell is looking after the digital needs of the administration, students and teachers for online teaching, examination and evaluation through licensing various platforms offering learning management system. A new website of the university, which is informative and dynamic has been designed. ICT cell has registered with Digilocker to provide digital degree to the passed out graduates of the University.

**Medium of Instruction**

The medium of instruction in all academic programmes is English. It is, therefore, necessary for all students to possess high standards of competence in the language for proper comprehension.

## ADMISSION AND ENROLMENT

The procedure how to apply for the Undergraduate (UG) Programmes {B.V.Sc. & A.H., B.Sc.(Hons.) Agriculture and B.Tech. (Food Technology)}, Masters' Programmes {M.Sc. Agriculture, M.V.Sc., M.Sc. Community Science and M.Sc. Basic Sciences} and Doctoral Programmes (Ph.D. Agriculture, Ph.D. Veterinary & Animal Sciences, Ph.D. Community Science and Ph.D. Basic Sciences) of the University, payment of application fee, regarding last date for receipt of online application form, mode of admission, other important dates, etc., the detailed information has been given under "Important Information" in the beginning.

**Rejection of Application**

Incomplete application or the application not accompanied with requisite application fee shall be rejected straightway.

**Academic Programmes**

For the Academic Year 2025-26, the University offers admission to B.V.Sc. & A.H. on the basis of NEET (UG)-2025 score; for B.Sc. (Hons.) Agriculture & B. Tech. (Food Technology) on the basis of CUET (UG)-2025 score; M.Sc. Agriculture, M.V.Sc., M.Sc. Community Science and M.Sc. Basic Sciences programmes on the basis of ICAR AIEEA (PG)-2025 and Doctoral programmes on the basis of ICAR AICE-JRF/SRF (Ph.D.)-2025. The other programmes B.Sc. (Hons./Hons. with Research) Physical Sciences (Physics/ Chemistry / Mathematics), B.Sc.(Hons./Hons. with Research) Life Sciences (Botany/Zoology/Chemistry), B.Sc. (Hons.) Community Science and B.Sc. (Hospitality and Hotel Administration) programmes, the admission is based on *merit* of the qualifying examination and the detailed information has been given in the respective Information Brochure and Prospectus for Merit Based Admissions 2025-26 available on the University website.

**Note:**

- i. The entrance test score in NEET (UG)-2025/ CUET (UG)-2025/ICAR AIEEA (PG)-2025/ AICE-JRF/SRF (Ph.D.)-2025 and percentage of marks in qualifying examination will be considered.
- ii. Where two or more candidates obtain equal marks in the NEET (UG)-2025/ CUET (UG)-2025/ ICAR AIEEA (PG)-2025/ AICE-JRF/SRF (Ph.D.)-2025 as the case may be, for admission to the respective programme, their merit will be decided on the basis of rank in the respective test. In the eventuality of same rank **or where rank not awarded**, for admission to Undergraduate programmes, the merit will be decided on the basis of percentage of aggregate marks obtained in the subjects of Physics, Chemistry and Biology/ Biotechnology/Mathematics/Agriculture of 10+2 examination or its equivalent examination; for Masters and Doctoral programmes, the merit will be decided on the basis of performance in the qualifying examination. If still there is a tie, then the candidate older in age will be considered higher in the merit.
- iii. **No candidate shall be admitted in Undergraduate programmes unless:**
  - a. He/she attains 17 years of age by 31<sup>st</sup> December, 2025 {except B.Sc. (Hons.) Agriculture and B. Tech. (Food Technology) where age criteria of ICAR i.e. Indian Nationals of at least 16 years of age as on 31.08.2025 shall be applicable}.
  - b. He/she must have acquired the minimum eligibility qualification on the date of Counseling-cum-Registration & Admission to the programme.

**Time of Admission**

Admission to B.V.Sc. & A.H., B.Sc. (Hons.) Agriculture, B.Tech.(Food Technology), Masters' programmes in Agriculture/Basic Sciences/Community Science/Veterinary Sciences and Doctoral programmes in Agriculture/Veterinary/Community Science/Basic Sciences shall be made at the commencement of beginning of semester of the academic year only.

Community Science} as well as the Major Subject Groups of ICAR AIEEA(PG)-2025 in which he/she is willing to be considered for admission at this University. The admission of the candidate will be considered in the same discipline(s) of Master's programme of this University i.e. in the sub-subjects of Major Subject Groups of ICAR AIEEA(PG)- 2025 in which he appeared in ICAR AIEEA(PG)-2025. Accordingly, he/she will have to mention the choice of discipline/subject (in writing) in order of preference in the online application form and if found eligible, he/she will be considered for admission in order of his/her preference of choice opted. Once the choice is exercised, change of discipline/ subject will not be allowed. However, if the seats in Master' programmes remain vacant at the time of final counseling/mop-up round, the said seats will be filled up on spot from AIEEA(PG)-2025 on merit irrespective of major subject groups and sub-subjects of AIEEA(PG)-2025.
- vi. The candidates must produce proof for the successful completion of all the course requirements for the eligibility qualification alongwith final OGPA/OGPA/percent marks on the day of counseling. Such candidates shall have to produce original/provisional certificate of the qualifying examination at the time of Counseling-cum-Registration & Admission. The candidates for admission to Masters' programmes are required to show/produce PDC /proof of completion of qualifying degree duly counter signed by the Registrar. Photocopy or mailed copy will not be entertained.
- vii. In case of in-service candidates, the minimum qualifying marks for admission to postgraduate programme shall be relaxable by 5% in case of general and 10% in case of Scheduled Castes/ Scheduled Tribe/ Person with Benchmark Disability category candidates.
- viii. An OCPA/OGPA/CGPA in qualifying examination of candidate shall be converted into percentage of marks as per conversion formula prescribed by the University from where examination is passed. **c) Doctoral Programme**

The minimum eligibility qualification for admission to Doctoral programme shall be an OCPA/OGPA of 6.50/10.00 or 3.25/5.00 or 2.60/4.00 or 60% marks (where grade points are not awarded) for Gen./OBC/EWSs category and an OCPA/OGPA of 5.50/10.00 or 2.75/5.00 or 2.20/4.00 or 50% marks (where grade points are not awarded) for SC/ST/Person with Benchmark Disability category at the post-graduation level (as shown against respective discipline) from a university established by law in India.

A degree of a foreign University (with at least 'B' grade or its equivalent) recognized as equivalent for the purpose by the University with good knowledge of English.

## Number of Seats and Distribution

### A. Number of Seats

The total number of students to be admitted in an Academic Year against University seats {(HP Bonafide & over and above) and ICAR/VCI} and EWSs (*Over and above the total seats*) for all degree programmes is fixed by the Academic Council and it shall not be reviewed for that Academic Year. The number of seats for the Academic Year 2025-26 is listed in **Table 1, 2 and 3**.

### B. Distribution of seats

#### 1. Undergraduate Programmes [B.V.Sc. & A.H., B.Sc.(Hons.) Agriculture and B.Tech.(Food Technology)]

- a. The seats in each programme shall be bifurcated and filled up by the University as under:
  - (i) **HP Bonafide Seats:** These seats are for the candidates who are Bonafide Himachali as defined in H.P. Govt. Revenue Law or who have passed at least 2 out of 3 (8<sup>th</sup>, 10<sup>th</sup> & 12<sup>th</sup> standard) examinations from schools/colleges situated in the territorial jurisdiction of Himachal Pradesh.
  - (ii) **Over and above Seats:** These seats are for In-service nominees, Ward of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (non-migrants), PM-USP for UT of J & K and Ladakh, Single girl child belonging to Himachal Pradesh, NRI/OCI/Foreign Nationals, Erstwhile Khalet/Rajpur Panchayats and Self Financing candidates.
- b. 20% of the total seats in B.Sc. (Hons.) Agriculture and 10% seats on it for EWSs under ICAR quota and 15% seats in B.V.Sc. & A.H. programme under VCI quota will be filled up through nomination by the ICAR/VCI.
- c. 10% of the total seats *excluding the ICAR quota for EWSs shall be reserved under the category of over and above seats for H.P. Bonafide Economically Weaker Sections candidates.*

#### 2. Master's Programme

- a. The seats in each programme shall be bifurcated and filled up by the University as under:
  - (i) **HP Bonafide Seats:** These seats are for the candidates who are Bonafide Himachali or who have passed their qualifying examination from the institutions/universities situated in territorial jurisdiction of Himachal Pradesh.
  - (ii) **Over and above Seats:** These seats are for In-service nominees, Wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (non-migrants), Sports/Co-Curricular Activities, NRI/OCI/Foreign Nationals, Fellowship Awardees, Ward of Freedom Fighters, Person with Benchmark Disability and Self-Financing candidates.
- b. 30% seats of total seats in M.Sc. Agriculture, M.V.Sc. and M.Sc. Community Science programmes and 10% seats on it for EWSs under ICAR quota will be filled through nomination by the ICAR.
- c. 10% of the total seats *excluding the ICAR quota for EWSs shall be reserved under the category of over and above seats for H.P. Bonafide Economically Weaker Sections candidates.*

### 3. DOCTORAL PROGRAMME

- a. The total seats in Doctoral programme shall be bifurcated and filled up by the University as under:

- (i) **HP Bonafide Seats:** These seats are for the candidates who are Bonafide Himachali or who have passed their qualifying examination from the institutions/universities situated in territorial jurisdiction of Himachal Pradesh.
  - (ii) **Over and above Seats:** These seats are for In-service nominees, Ward of Freedom Fighter, Person with Benchmark Disability, NRI/OCI/Foreign Nationals, Fellowship Awardees and Self-financing candidates.
- b. 30% seats of total seats in Ph.D. Agriculture, Ph.D. Veterinary Sciences, and Ph.D. Community Science programmes and 10% on it for EWSs under ICAR quota will be filled through nomination by the ICAR.
  - c. 10% of the total seats *excluding the ICAR quota for EWSs* shall be reserved under the category of over and above seats for *H.P. Bonafide Economically Weaker Sections* candidates.

Further distribution of seats under 1 (a)(i), 2(a)(i) and 3(a)(i) above:

- i. 15% and 7.5% seats will be reserved for the students belonging to the Scheduled Caste and Scheduled Tribe categories respectively. In case, the requisite numbers of candidates from a particular reserve category i.e. Scheduled Caste or Scheduled Tribe are not available, it will be filled up from the Scheduled Tribe or Scheduled Caste category, as the case may be, but the total reservation will not exceed 22.5%.
- ii. 2% seats in each programme shall be reserved for the wards of freedom fighters in accordance with the instructions of the HP Govt. on the issue as amended from time to time. "Freedom Fighter" is a person as declared so by the H.P. Govt. 'Wards' means and includes Children/Grand Children (only from paternal side) of the Freedom Fighter. Provided the benefit can also be extended to the sons/daughters (from maternal side) of a Freedom Fighter subject to the condition that the Freedom Fighter is/was not having a son. They are required to produce a certificate as per Form-IX of Annexure III of the Prospectus.
- iii. One seat in each Undergraduate Programme shall be reserved for the sons/daughters of the serving/ex-defence personnel. Merit being equal, preference shall be given to the sons/daughters of serving/ex-defence personnel who is a gallantry award winner. In case, two candidates are sons/daughters of serving/ex-defence personnel who are also gallantry award winners, then the candidate older in age will be placed higher in merit. "Defence Personnel" means serving personnel in one of three wings of Armed Forces i.e., Army, Air Force and Navy, their wards shall apply under this category according to Form IV of Annexure III for which they are required to produce a certificate as per Form IV of the Prospectus. Similarly, "Ex-Serviceman" means retired personnel of three wings of Armed Forces i.e., Army, Air Force and Navy, their widows/wards shall apply under this category according to Form-IV, for which they are required to produce a certificate as per Form-IV of Annexure III of the Prospectus.

**Note:** *The allotment of seats under the above mentioned categories shall be made strictly as per priority basis as mentioned in Form IV of Annexure III of the Prospectus.*

- iv. 5% seats for admission in each Undergraduate programme and 5% seats for admission in Masters' and Doctoral Programmes (college-wise) shall be reserved, **horizontally across the categories** in different programmes for Person with Benchmark Disability. "Person with benchmark disability" means a person with not less than 40% of a specified disability where specified disability has not been defined in measurable terms and include a person with disability where, specified disability has been defined in measurable terms as certified by the certifying authority. The medical standards for the candidate (other than B.V.Sc. & A.H. degree) to be considered under physically disabled category are low vision, hearing impairment, locomotors disability or cerebral palsy having at least 40% disability. The decision of the University authority will be final in this regard. The candidates applying for admission under this category should submit a self-attested copy of the certificate being disabled at the time of counseling.

Further, for B.V.Sc. & A.H., a candidate shall not be allowed admission if he/she suffers disabilities in physical fitness as listed below:

- a. Disability of total body including disability of chest or spine more than 50%.
- b. Disability of lower limb more than 50%.
- c. Disability of upper limb.
- d. Visually disabled candidates and those with hearing disability.
- e. Candidate with progressive diseases like myopathies, etc.
- f. Disability, which otherwise would interfere in the performance of the duties of a veterinarian.

**Note:** *The disability shall be certified by a duly constituted and Government authorized Medical Board*

*comprising of at least three specialists out of which two shall be of the specialty concerned and the candidate has to present him or herself before the Medical Board and the last valid disability certificate of the candidate from a Medical Board shall not be more than six months old from the date of counseling. However, the Permanent Disability Certificate issued by the authorized Medical Board will be acceptable.*

- v. One seat each in B.Sc. (Hons.) Agriculture, B.V.Sc. & A.H. and B.Tech.(Food Technology) programme shall be reserved for the candidates belonging to Other Backward Classes (OBC). The candidates applying for admission under this category shall have to submit a self-attested copy of the certificate of OBC (FORM V of Annexure III) at the time of counseling failing which their candidature under the category shall not be considered.
- vi. One seat each in B.Sc. (Hons.) Agriculture, B.V.Sc. & A.H. and B.Tech.(Food Technology) programme will be reserved for the candidates excelling in sports/co-curricular activities including NCC/NSS/Scouting. The admission under sports/co-curricular activities will be governed as per the criteria mentioned in **Annexure I**.

Further distribution of seats under 1 (a) (ii), 2(a)(ii) and 3(a)(ii) above:

#### **1. Undergraduate Programmes**

##### **a) In-service nominees**

- i. In B.V.Sc. & A.H. one seat each shall be reserved for the in-service Veterinary Pharmacist **nominee of the H.P. Govt. as well as CSKHPKV, Palampur**, provided he/she has minimum 50% marks in the aggregate of English, Physics, Chemistry and Biology/Biotechnology and the sponsorship of the said candidate by the respective department of Animal Husbandry, Govt. of H.P./ CSKHPKV, Palampur, H.P., as the case may be, must reach on or before the final round of Counseling-cum-Admission (upto 11.00 AM).
- ii. In B.Sc. (Hons.) Agriculture, two seats shall be reserved for in-service **nominees of the H.P. Govt., 2 seats for ICAR nominee and 1 seat for the nominee of CSKHPKV, Palampur**, provided the candidate has minimum 50% marks in the aggregate of English, Physics, Chemistry, Biology/Mathematics/Agriculture with at least pass marks in each subject in the qualifying examination and the sponsorship of the candidate by the respective Govt. of H.P., ICAR and CSKHPKV, Palampur, as the case may be, must reach on or before the final round of Counseling-cum-Admission (upto 11.00 AM).

##### **b) Candidates from erstwhile Khalet & Rajpur Panchayats**

Two candidates each from erstwhile **Khalet & Rajpur Panchayats** would be admitted in B.Sc. (Hons.) Agriculture provided they fulfill the minimum qualifications as prescribed for admission to the programme and have appeared in CUET (UG)-2025 and their merit will be decided on the basis of score card of said test.

Provided that the benefit of reservation can be availed only by the heirs/sons/daughters of those residents of respective erstwhile Panchayats who were residing in the concerned erstwhile Panchayat area prior to July 4, 1966 and who still continue to reside and have proprietary rights in the concerned erstwhile Panchayat. The candidate must produce certificate to this effect on the prescribed proforma (Form VIII of Annexure III) issued by the SDM/Executive Magistrate. Provided further that, if any candidate belonging to any such erstwhile Panchayat comes in the open merit, the reservation of seat to that extent will stand exhausted.

**Note:** The Candidate seeking admission against the seat reserved for the erstwhile RAJPUR/KHALET Panchayat shall also submit a copy each of 'SHAJRA NASAB' and 'JAMABANDI' from the Patwari concerned to prove that the ancestors of the candidate owned land and held proprietary rights in the concerned erstwhile Panchayat and he /she still enjoys those rights at present and also residing in the same erstwhile Panchayat.

- c) **Wards of Kashmiri Migrant and Kashmiri Pandits/Kashmiri Hindu families (non-migrants):** One seat each in B.Sc. (Hons.) Agriculture, B.V.Sc. & A.H. and B.Tech.(Food Technology) programme shall be reserved for Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (non-migrants) who have appeared in NEET (UG)-2025 {for admission to B.V.Sc. & A.H. programme} / CUET (UG)-2025 { For admission to B.Sc.(Hons.) Agriculture/B.Tech. (Food Technology) programme}. For this category candidates, the marks in qualifying examination shall be relaxable by 10%. In case, two or more such candidates appear in the counseling-cum-admission, the seat shall be filled on the basis of merit in the respective test. The candidates applying for admission under this category shall have to submit a self- attested copy of the certificate as per Form VI of Annexure III issued by the District Magistrate of origin of the person, at the time of counseling, failing which his/her candidature under this category shall not be considered.

- d) **PM-USP for UT of J & K and Ladakh:** Two seats *each* in B.Sc. (Hons.) Agriculture, B.V.Sc. & A.H. and

B.Tech.(Food Technology) programme shall be reserved for PM-USP for UT of J & K and Ladakh.

- e) **Single Girl Child (belonging to Himachal Pradesh):** One seat each in B.Sc. (Hons.) Agriculture, B.V.Sc. & A.H. and B.Tech.(Food Technology) programme shall be reserved for single girl child belonging to Himachal Pradesh. "Single Girl Child" means parent having a single girl child without any sibling subject to fulfillment of eligibility criteria as prescribed for State Quota Seats. Under this category, the candidate has to produce a certificate at the time of counseling-cum-admission as per Form VII of Annexure-III duly issued by the Sub-Divisional Magistrate/Executive Magistrate/Tehsildar/Block Development Officer of the area concerned to which the parents of the candidate belong. It should be signed by the issuing authority and not countersigned.
- f) **Self-Financing Seats:** These seats are for those candidates who are willing to take admission in a particular programme in the University but could not on the basis of their rank and have opted out to pay the extra fee in addition to the usual fee. However, the admission under these seats is also done on the basis of score of the NEET (UG)-2025/ CUET (UG) -2025 as per the mode of admission.
- g) **NRI/OCI Candidates:** Number of seats not exceeding 15% of the HP Bonafide seats under B.V.Sc. & A.H. and B.Sc. (Hons.) Agriculture programmes shall be reserved for Non-Resident Indians (NRIs)/OCIs category candidates and shall be filled on the merit of eligibility qualification. "NRI candidates" means persons who do not reside in India and who are Non-Resident Indians (Residing abroad) OR Wards of Indian citizen residing abroad and who have passed their qualifying examination i.e. 12<sup>th</sup> standard which is equivalent to 10+2 Higher/Senior Secondary Examination or any other examinations equivalent thereto with requisite subjects from the School/College/University situated abroad. OCI Cardholder shall have parity with NRI.
- h) **Foreign Nationals:** Number of seats not exceeding 10% of the HP Bonafide seats under B.Sc. (Hons.) Agriculture and B.V.Sc. & A.H. programmes shall be reserved for the candidates (other than those nominated/sponsored by Govt. of India/ICAR) from foreign countries and shall be filled on the merit of eligibility qualification.

## 2. Masters' programmes

### I. In-service Nominees of H.P. Government:

- i. One seat in College of Agriculture shall be reserved for in-service candidate nominated by H.P. Government provided he/she has minimum eligibility for the programme and the sponsorship of the said candidate must reach from the respective department of the Govt. of Himachal Pradesh on or before the final round of Counseling-cum-Registration & Admission (upto 11.00 AM).
- ii. One seat in each offered discipline of the College of Veterinary and Animal Sciences will be reserved for the in-service candidates nominated by the H.P. Govt. provided he/she has minimum eligibility for the programme and the sponsorship of the said candidate must reach from the respective department of the Govt. of Himachal Pradesh on or before the final round of Counseling-cum-Admission (upto 11.00 AM).

- II. **In-service Nominees of CSKHPKV:** One seat in each college will be reserved for the in-service candidate nominated by CSKHPKV provided he/she has minimum eligibility for the programme.
- III. **Sports/Co-Curricular Activities:** One seat in each College will be reserved for candidates excelling in sports/co-curricular activities including NCC/NSS/Scouting. The admission under sports/co-curricular activities will be governed as per the criteria mentioned in **Annexure I**.
- IV. **Wards of Kashmiri Migrant and Kashmiri Pandits/Kashmiri Hindu families (non-migrants):** One seat in each college will be reserved for Ward of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (non-migrants) who appeared in ICAR AIEEA (PG)-2025. In this case, qualifying marks in degree examination shall be relaxable by 10%. In case, two or more such candidates appear in the counseling, the seat shall be filled on the basis of merit as per mode of admission. The candidates applying for admission under this category shall have to submit a self-attested copy of the certificate to this effect at the time of counseling **as per Form-VI of Annexure III**, failing which his/her candidature under this category shall not be considered.
- V. **Fellowship Awardees:** One seat in each discipline shall be reserved for candidates who have been awarded fellowship by CSIR/UGC/BARC/DST. For this, the candidates shall have to appear in Counseling-cum-Registration & Admission-II in the respective programme of the University. In case, two or more such candidates appear in the counseling, preference would be given to candidates possessing higher percentage of marks in qualifying degree examination.
- VI. **Person with Benchmark Disability:** Two seats in College of Agriculture, two seats in Dr. G.C. Negi

- COVAS and one seat in College of Community Science subject to maximum one seat in the discipline of the concerned College will be reserved for the Person with Benchmark Disability.
- VII. **Ward of Freedom Fighter:** One seat each in College of Agriculture and Dr. G.C. Negi College of Veterinary & Animal Sciences will be reserved for Ward of Freedom Fighter.
  - VIII. **Self-Financing Seats:** These seats are for those candidates who are willing to take the admission in a particular programme in the University but could not on the basis of their rank and have opted to pay the extra fee in addition to the usual fee. However, the admission under these seats is also done on the basis of the ICAR AIEEA (PG)-2025 as per mode of admission.
  - IX. **NRI/OCI Candidates:** Number of seats not exceeding 15% of the HP Bonafide seats in College of Agriculture and Dr. G.C. Negi College of Veterinary & Animal Sciences shall be for Non-resident Indians (NRIs)/OCI category candidates and shall be filled on *merit* of eligibility qualification subject to a maximum of two seats in any one discipline.
  - X. **Foreign Nationals:** Number of seats not exceeding 10% of the HP Bonafide seats in College of Agriculture and Dr. G.C. Negi College of Veterinary & Animal Sciences shall be for the candidates (other than those nominated/sponsored by Govt. of India/ICAR) from foreign countries and shall be filled on the *merit* of eligibility qualification.

### 3. Doctoral programmes

1. **In-service Nominees of H.P. Government:** One seat in Doctoral programme in each College will be reserved for the in-service candidate nominated by H.P. Government provided he/she has minimum eligibility for the programme and the sponsorship of the said candidate must reach from the respective department the Govt. of Himachal Pradesh on or before the final round of Counseling-cum-Admission (upto 11.00 AM).
2. **In service Nominees of CSKHPKV:** One seat in each discipline of Doctoral programme will be reserved for the in-service candidate nominated by CSKHPKV, Palampur.
3. **Person with benchmark disability:** One seat in Doctoral programme of College of Agriculture will be reserved for Person with benchmark disability.
4. **Fellowship Awardees:** One seat in each discipline of Doctoral programme shall be reserved for candidates **who have been awarded fellowship by CSIR/UGC/BARC/DST. For this, the candidates shall have to appear in** Counseling-cum Registration & Admission-II in the respective programme of the University. In case, two or more such candidates appear in the counseling, preference would be given to candidates possessing higher percentage of marks in qualifying degree examination.
5. **Self-Financing Seats:** These seats are for those candidates who are willing to take the admission in a particular programme in the University but could not on the basis of their rank and have opted to pay the extra fee in addition to the usual fee. However, the admission under these seats is also done on the basis of the ICAR AICE-JRF/SRF(Ph.D.)-2025 as per mode of admission.
6. **NRI/OCI Candidates:** Number of seats not exceeding 15% of the sanctioned seats under Doctoral programme in the College of Agriculture shall be reserved for Non-Resident Indians (NRIs/OCI) category candidates and shall be filled on the inter-se-merit of Master's Degree subject to a maximum of two seats in any one discipline. "NRI candidates" means wards of Indian citizen residing abroad and who have passed their qualifying examination or any other examinations equivalent there to with requisite subjects from the School/College/University situated abroad.
7. **Foreign Nationals:** Number of seats not exceeding 10% of the sanctioned seats under Doctoral programme in the College of Agriculture shall be reserved for the candidates (other than those nominated/sponsored by Govt. of India/ICAR) from foreign countries and shall be filled on merit as per mode of admission subject to a maximum of one seat in any one discipline.

### Seats under B(1)(c), B(2)(c) and B(3)(c)

**Economically Weaker Sections (EWSs):** As per letter No. PER(AP)-C-B(12)-1/2019 dated 11.06.2019 from the Chief Secretary, Government of HP, the person who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.4.00 lakh (Rupees four lakh only) are to be identified as Economically Weaker Sections (EWSs) for the benefit of reservation. Income shall also include income from all sources i.e., salary, agriculture, business, profession, etc. for the financial year prior to the year of application. Also, persons whose family owns or possess any of the following assets shall be excluded from being identified as EWSs, irrespective of the family income:

- i. More than 1 hectare of Agricultural Land in rural areas and 500 M<sup>2</sup> land in urban areas;
- ii. Residential flat/house of more than 2500 square feet in rural/urban areas.

- iii. Family of income tax payee;
- iv. Family of Regular/Contract employees of the Central Government, State Government, Board, Corporations and autonomous bodies and Public Sector Undertakings, etc.;

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

**The candidates belonging to unreserved B.P.L. category are not required to submit Income and Asset Certificate. They shall be treated as eligible for EWSs reservation on the basis of valid B.P.L certificate issued by competent authority and countersigned by the Block Development Officer and supplemented by the non-SC/ST/OBC certificate issued by the Competent Authority.**



The format for “**Income & Asset Certificate to be Produced by the Economically Weaker Sections**” {Form X(i)} and “**Non-SC/ST/OBC Certificate to be produced by the Candidate belonging to B.P.L. category**” {Form X(ii)} of Government of Himachal Pradesh will be applicable for the purpose.

**Note:**

- i. While calculating reservations, fraction less than 0.5 will be ignored and 0.5 or above will be taken as one seat.
- ii. The candidature of in-service candidates will be considered valid only if they are sponsored by the Government of Himachal Pradesh/ ICAR/ CSKHPKV, Palampur by the final round of counseling-cum-admission/mop up round upto 11.00 AM.
- iii. The reservation for SC/ST candidates in Masters’ and Doctoral programmes have been made in accordance with 100 point roster system in each college by arranging disciplines alphabetically.
- iv. First of all, seats in general category will be filled up for admission through Counseling-cum- Registration & Admission – I for which the candidates shall have to report by 11.30 AM. The candidates of reserved categories who are able to find place in the general merit in Counseling-cum- Registration & Admission – I will be considered against the general category seats. The seats remaining vacant from Counseling-cum- Registration & Admission – I will be filled from the waiting list on the day of Counseling-cum- Registration & Admission–II for which eligible candidates from waiting list to be issued by the University on its website who are already admitted on the day of Counseling-cum- Registration & Admission–I against any category seat and his/her name figures in merit in other category, shall have to report for Counseling-cum- Registration & Admission–II for admission against the said category. After admitting candidates through Counseling- cum- Registration & Admission–II from waiting list, the said waiting list shall cease to exist/closed.
- v. The seats remaining vacant after admitting the candidates from the Counseling-cum- Registration & Admission–I and II or fall vacant thereafter in any programme, the same will be filled category wise on merit as per the mode of admission at the time of final round of counseling/mop-up round on the specified date. If the seats in any category {except the categories of ICAR/VCI, Wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (non-migrant), in-service nominee of H.P. Government/CSKHPKV Palampur nominee, PM-USP for UT of J & K and Ladakh, Fellowship Awardees, NRIs/OCIs/Foreign Nationals and Self-Financing seats} remain vacant due to non-availability of eligible candidates, will be added to general category at the time of final round of counseling/mop-up round on the spot subject to the condition that where such seats remain vacant in Masters’ and Doctoral programmes at the college level will be clubbed and allotted amongst the disciplines (except the discipline where the seats of any such category/categories including over and above seat(s) have already been filled up) of concerned college proportionately under general category by the Counseling Committee on the spot and filled up accordingly except B.V.Sc. & A.H. programme where the seats lying vacant under SC/ST of HP Bonafide category shall be filled up on All India Basis from the candidates belonging to SC/ST category at the time of final round/mop up round. **During this process, if seats of H.P. Bonafide remain vacant, the non- HP Bonafide candidates can also be considered.**
- vi. In case the ICAR’s/VCI counseling concludes and the seats remain vacant under B 1(b), B 2(b) and B 3(b), the same will be filled up by the University on merit as per mode of admission at the time of final round of counseling/mop-up round and will be open to all eligible candidates with the condition that these seats will be filled up after filling up the vacant seats of H.P. Bonafide at the time of final round of counseling/mop-up round.
- vii. In case, seat(s) of in-service nominee of H.P. Government/CSKHPKV Palampur nominee/ICAR nominee category remain vacant in undergraduate programme at the time of final round of counseling/mop up round, these will be converted to Self-Financing Seats (SFS) on the spot and will be filled up by the University on merit as per mode of admission at the time of final round of counseling/mop-up round.
- viii. In case, seat(s) under Foreign National category remains vacant in undergraduate/Masters/Doctoral programmes, it will be offered to NRIs /OCIs category candidates.
- ix. In case, seat(s) under NRIs/OCIs category remains vacant in undergraduate programmes, these will be converted to Self-Financing Seats (SFS) and shall be filled up at the time of final round of counseling/mop-up round.
- x. If the seats of Wards of Kashmiri Migrants and Kashmiri Pandits/ Kashmiri Hindu families (non-migrants), PM-USP for UT of J & K and Ladakh in Undergraduate Programmes remain vacant at the time of final round of counseling/mop-up, these will be converted to self-financing seats (SFS) on the spot and will be filled up at time of final round of counseling/mop-up round.

**General Instructions for Selection of Candidates for admission:**

1. The candidate seeking admission to **Undergraduate Programmes {B.V.Sc. & A.H./ B.Sc. (Hons.) Agriculture/B.Tech.(Food Technology), Masters' Programmes {M.V.Sc./M.Sc. Ag./ M.Sc. Basic Sciences/M.Sc. Community Science} and Doctoral Programmes {Veterinary & Animal Sciences/ Agriculture/Community Science/Basic Sciences}, the candidates shall first of all have to fill the online application form at the University Website <http://hillagric.ac.in> along with all the requisite certificates/documents relating to admission as mentioned in Counseling proforma (Annexure IX) to be uploaded on the University website.**

2. All the candidates seeking admission to B.V.Sc. & A.H. programme must have to appear in the National Eligibility cum Entrance test NEET(UG)-2025; for B.Sc. (Hons.) Agriculture and B.Tech.(Food Technology) programmes in the CUET (UG)-2025; for Master's Programmes in ICAR AIEEA (PG)-2025 and for Doctoral Programmes in ICAR AICE-JRF/SRF (Ph.D.)-2025 **to be conducted by the National Testing Agency (NTA) except NRIs/OCIs/Foreign Nationals/Inservice/PM-USP for UT of J & K and Ladakh candidates.** The admission shall be purely on the basis of merit score of respective entrance tests and there will be no minimum cut-off marks in the said entrance tests for applying to these programmes.
3. The NRI/OCI and Foreign National category candidates **are advised to go through the rules and regulations for admission of NRI/OCI and Foreign National category candidates mentioned in the Information Brochure & Prospectus and their application must reach in the office of the Registrar, CSKHPKV, Palampur 176062 by the last date for receipt of such application forms failing which the candidature of the Foreign National/NRI/OCI will not be considered.**
4. A candidate shall have to mention his/her personal details (name, father's name, mother's name as mentioned in NEET(UG)-2025/ CUET (UG)-2025 / ICAR AIEEA (PG)-2025/ ICAR AICE-JRF/SRF(Ph.D.)-2025; programme applied for; category particulars (such as General, etc.) correctly while **submitting the Online Application Form.** The candidature of the candidate will only be considered against the specific category for admission as he/she has **applied for the said category at the time of filling Online Application Form for the respective programme.** The candidate will be required to present the proof of reserved category as claimed by him/her in original for verification at the time of counseling-cum- Registration & Admission.
5. In addition to the candidate's own category, the candidate can also opt for Self-financing seat by paying the additional fee for self-financing seat(s) of the programme at the time of filling online application form. **Further, if the candidate does not opt for self-financing seat at the time of filling online application form, his/her candidature for self-financing seat will not be considered for admission in SFS category even at the time of admission through final round of counseling/mop-up round.**
6. The Non-HP Bonafide candidates can only apply for self-financing category seat(s).
7. ***Where two or more candidates obtain equal marks in the NEET (UG)-2025/ CUET (UG)-2025/ ICAR AIEEA (PG)-2025/ AICE-JRF/SRF (Ph.D.)-2025 as the case may be, for admission to the respective programme, their merit will be decided on the basis of rank in the respective test. In the eventuality of same rank or where rank not awarded, for admission to Undergraduate programmes, the merit will be decided on the basis of percentage of aggregate marks obtained in the subjects of Physics, Chemistry and Biology/ Biotechnology/ Mathematics/Agriculture of 10+2 examination or its equivalent examination; for Masters and Doctoral programmes, the merit will be decided on the basis of performance in the qualifying examination. If still there is a tie, then the candidate older in age will be considered higher in the merit.***
8. The candidates who have appeared in the qualifying examination with requisite subjects (even if result is yet to be declared) can also apply, however, such candidates will be considered for admission on merit score of the respective entrance tests provided they fulfill the eligibility conditions and produce all the original documents including the original marks sheet/PDC/proof of completion of qualifying degree duly countersigned by the Registrar at the time of document verification failing which their candidature will not be considered.
9. The online application form details furnished by the candidate shall be freezed immediately after the last date fixed for submission of the online application form and the candidate shall not have any access to the said details submitted by him/her. This submission will generate a receipt of partial successful submission of the online application form to the applicant. The receipt will show in the profile of candidates.
10. The candidates for applying to B.V.Sc. & A.H., B.Sc. (Hons.) Agriculture and B.Tech. (Food Technology) programmes shall have to furnish the information with respect to : Roll Number issued by the National Testing Agency, 2) Total Marks obtained and 3) ALL INDIA RANK/OVERALL RANK obtained by the candidate in NEET (UG)-2025/ CUET (UG)-2025 as the case may be in the online application form by uploading the respective Score Card of the respective Entrance Test by the stipulated date. As soon as ICAR AIEEA (PG)-2025/ ICAR AICE-JRF/SRF (Ph.D.)-2025 result is declared, the University will issue a notification on its website for the candidates to Masters' and Doctoral Programmes to complete the online application process for updating the online application form to furnish the information with respect to : Roll Number issued by the National Testing Agency, 2) Total Marks obtained and 3) ALL INDIA

RANK/OVERALL RANK obtained by the candidate in ICAR AIEEA (PG)-2025/ ICAR AICE-JRF/SRF (Ph.D.)-2025 and by uploading the 4) SCORE CARD of respective Entrance Test. All the candidates must complete the said process within the stipulated time failing which his/her right for admission to the programme(s) through Counseling-cum-Registration and Admission-I and II shall stand forfeited and no correspondence in this regard will be made. However, such candidates can participate/take part in the final round of counseling/mop up round for admission to the respective programme. The candidates must ensure that he/she has furnished the correct 1) Roll Number issued by the National Testing Agency, 2) Total Marks obtained and 3) ALL INDIA RANK/OVERALL RANK obtained in NEET (UG)-2025 / CUET (UG)-2025/ ICAR- AIEEA (PG)-2025/ ICAR AICE-JRF/SRF (Ph.D.)-2025 in his/her online application form within the stipulated time failing which his/her candidature for admission will not be considered and the individual will be solely responsible for it. At this time, no candidate shall be allowed to rectify/add/modify their information/particulars already filled in their online application form.

11. The competent authority shall reserve the right to reject any admission form with reasons to be recorded in writing.
12. The University will issue the category wise provisional Select/Waiting list of the shortlisted candidates for admission to the respective programme in order of merit subject to fulfilling the eligibility criteria on the University Website <http://hillagric.ac.in> before the start of Counseling -cum- Registration & Admission - I which will be purely temporary. If any candidate has any objection or finds that his/her name is missing in the said shortlisted list, he/she will be free to point out the same within 48 hours by writing to the Registrar, CSK HPKV, Palampur through e-mail [contactpetcskhpkv@gmail.com](mailto:contactpetcskhpkv@gmail.com) by mentioning his/her application number and name failing which no claim/representation of the candidate will be entertained thereafter. After verification the objection, if any, raised/pointed out by the candidate(s), the final provisional select list/waiting list for Counseling -cum- Registration & Admission - I to the respective programme will be issued separately which shall also be available on the University Website <http://hillagric.ac.in> containing all the instructions/procedure for counseling-cum- Registration & Admission - I to the programme. If any correction/error is noticed during verification, the same shall also be rectified by the University for which no objection will be entertained. This will be followed by Counseling -cum- Registration & Admission – I/II.
13. *The candidates maximum 3-5 times of the total intake capacity in each category, in order of merit as per mode of admission shall be called on the date of Counseling-cum- Registration & Admission-I to report by 11.30 AM. The list of such candidates will be available on the University web site, before the date of Counseling-cum- Registration & Admission– I. The candidature of the candidates reporting after 11.30 AM shall not be considered/entertained. The candidate(s) who finds himself/herself selected through Counseling-cum- Registration & Admission-I process, shall have to deposit the requisite fee and get himself/herself registered by 4.00 PM on the same day failing which his/her claim for the said seat shall be forfeited and he/she shall have no right for his/her admission from the waiting list to be issued by the University. However, such candidates can participate/take part in the final round of counseling/mop up round for admission to the respective programme.*
14. The seats remaining vacant from the **Counseling-cum- Registration & Admission -I** to a programme, shall be filled from the waiting list of the candidates to be notified by the University on the University web site. The waiting list shall consist the name of the candidates for **Counseling-cum- Registration & Admission-II** who reported on the day of **Counseling-cum- Registration & Admission-I** but could not be selected for admission except the candidates whose counseling was held on the day of counseling-cum-Registration & Admission-I but could not be selected for want of any document relating to admission, and the rest of the eligible candidates for the said programme. All such candidates shall have to report on the day of registration-cum- admission -II by 11.30 AM. *The candidature of the candidates reporting after 11.30 AM shall not be considered/entertained. The candidate(s) who finds himself/herself selected through Counseling-cum- Registration & Admission-II process, shall have to deposit the requisite fee and get himself/herself registered by 4.00 PM on the same day failing which his/her claim for the said seat shall be forfeited. However, such candidates can participate/take part in the final round of counseling/mop up round for admission to the respective programme.*
15. The candidate shall have to check his/her name in the respective Counseling-cum-Registration & Admission - I/II list of the concerned programme to be notified on the University website and shall have to appear before the Counseling-cum- Registration & Admission Committee on the scheduled date, time and venue for the respective date of Counseling-cum-Registration & Admission -I/II for document verification and other admission formalities in person failing which his/her right for admission for the respective programme shall be forfeited. The information regarding these Counseling-cum- Registration & Admission shall be displayed on the University

website. No correspondence in this regard will be made. Therefore, the candidates are advised to remain in touch with the University website. However, such candidates shall be eligible to appear in the final round of counseling/mop-up round for admission.

16. The candidates on confirmation of admission to a seat through Counseling-cum- Registration & Admission -I/II as the case may be shall have to pay fees and other charges on the same day except hostel charges at the time of counseling-cum- Registration & Admission otherwise the seat will be declared vacant and his right for admission shall stand cancelled and he/she will not be eligible for admission. Also, if any candidate remains absent at the time of document verification, fee deposition, the seat will be presumed to be vacant. Further, if a candidate refuses to accept admission at his/her own turn, he/she shall lose his/her right for admission to the programme. However, such candidates can appear in the final round of counseling/mop-up rounds of the respective programme.
17. **For the process of verification of documents, the candidates shall have to show Admit Card of respective Entrance Test along with all the original certificates/documents relating to admission to the Counseling-cum-Registration & Admission Committee at the time of Counseling-cum- Registration & Admission -I/II and also to submit the counseling proforma at Annexure-IX duly filled in all respects, to be downloaded from the University website along with two copies of recent his/her photograph along with two sets of self-attested photocopies of the certificates/documents relating to admission, at the time of document verification, failing which the candidate shall have no right for admission to the programme.**
18. After verification of documents including medical fitness certificate as per Annexure IV, the candidates shall deposit the fees by 04.00 PM and other charges on the same day in the office of the concerned Dean to complete the admission process on the same day.
19. **If a candidate vacates the seat, he/she shall have to give in writing and also request for refund of fee deposited by him with the University. In such cases, the fee will be refunded to him/her as per University rules.**
20. In case the seats remained vacant/fall vacant after the counseling-cum-Registration & Admission-I and II, the University may conduct the final round of counseling/mop-up round as per mode of admission, if required. For this, all the candidates who appeared in the respective entrance test and filled the online application form with requisite application fee for admission to the respective programme(s) of this University will only be entitled to appear for final round of counseling/mop-up round for admission to the respective programme. In case the seats of In-service nominees, NRI/OCI/ Foreign National candidates, Wards of Kashmiri Migrant and Kashmiri Pandits/Kashmiri Hindu families (non-migrants), PM-USP for UT of J & K and Ladakh remain vacant in undergraduate programme at the time of final round of counseling/mop-up round (up to 11.00 AM), such seat(s) shall be converted to Self-Financing Seat(s) and shall be filled up on the spot at the time of final round of counseling/mop-up round.
21. The record of the candidates who are not admitted even during the last round of counseling/mop-up round shall be destroyed after six months barring those related to the court cases, if any, and the record related to admission process/counseling shall be destroyed after six months after the last round of counseling/mop-up round except the record of any pending court case.

**Note:**

- i. *It is mandatory for the candidate to report for counseling-cum-registration and admission-I and II, as the case may be, on the specified time, date & venue (given in 'Important Information') and mark his/her attendance in the attendance sheet/register kept for the purpose, otherwise his/her candidature will not be entertained and his/her right to admission will be forfeited.*
- ii. **The Counseling-cum- Registration & Admission Committee on the day of Counseling-cum-Registration & Admission -I/II shall check and verify the eligibility of candidates for admission to the programme and on confirmation of admission of a seat to the programme the candidates shall have to pay the fee on the same day by 4.00 PM. The University will also provide the facility for the candidates to pay the fee on the spot. In case of final round of counseling/mop-up round, the Chairman of the Committee will declare the list of the selected candidates on the day of final round of counseling/mop-up round and display the same on the notice boards of the office of the concerned Dean/Dean, Postgraduate Studies with a copy to Registrar, CSKHPKV, Palampur. If a candidate fails to register himself/herself as per Mode of Registration and pay the fee by the due date of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit, in the respective category. The candidate shall be required to pay the fee as per procedure described in 'Important Information'. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.**

**Right of Petition**

No representation/petition will be entertained after the lapse of seven days from the Counseling-cum- Registration & Admission -I/II/mop up round.

## Registration

The registration of candidates selected for admission shall be completed on the day of counselling -cum-registration and admission -I/II, as case may be on the scheduled date(s) as described in '**Important Information**'. The registration in respect of B. V. Sc. & A.H. programme will be done for a professional year at the beginning of each academic year.

### Mode of Registration

- i. On the day of Counseling-cum- Registration & Admission -I/II as described under Important Information, on confirmation of admission to a seat and thereafter deposition of requisite fee the candidate shall meet his/her Advisor/ Tutor to get advice regarding registration of various courses and shall fill up a set of four differently coloured registration cards in person. After filling up the registration cards, the student shall contact concerned Course Instructors for enrolment in various courses entered in the registration cards.
- ii. On completion of registration cards as above, the student shall deposit the cards with the office of the concerned Dean of the College on the day of registration up to 4.00 PM.

### Refusal of Admission

1. At the time of Counseling-cum- Registration & Admission- I/II, the Committee shall also consider the past record of the candidate as a student in the previous institution. If, it is known that candidate being considered for admission has been involved in any act of misconduct/indiscipline in the hostels, in the college or elsewhere, the Counseling - cum admission Committee may refuse to recommend such a candidate for admission. Those who have been rusticated or debarred by the previous institution shall not be admitted to this University during the period of their disqualification.
2. The Vice-Chancellor, for reasons to be recorded in writing, reserves the right of refusing admission to any candidate, whose admission in the opinion of the Vice-Chancellor, is not in the interest of the University, even though he/she may fulfill the academic requirements for admission. Further, the Vice-Chancellor reserves the right of cancelling admission of any student without prior notice against whom an adverse report about his/her conduct has been received and his/her continuance is considered to be against the interests of the University. The decision of the Vice-Chancellor shall be final and binding on the candidate.
3. It is the responsibility of the candidate to furnish complete and correct information in the online Application Form. In case, any relevant information is concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate.

### Medical Fitness

The medical fitness certificate issued by the Medical Officer of any Govt. Hospital in the format given at **Annexure IV** as per medical and physical fitness standards prescribed in **Annexure V** must be produced at the time of counseling-cum-admission for admission to the programme. *In case a candidate is not found physically and mentally fit even after the admission, he/she will be referred to the Medical Officer of the University for the Medical Opinion.*

### Migration Certificate

The students who have passed their qualifying examination from an educational institution other than CSKHPKV are required to submit their **MIGRATION CERTIFICATE IN ORIGINAL before the start of end-term examination of first semester** otherwise they will not be allowed to sit in the examination.

### Rules & Regulations for Admission of NRI/OCI Candidates

The rules and regulations for admission of NRI/OCIs candidates in the University will be as below:

1. The NRI/OCI candidates shall have to apply for admission for the programme of their choice on the prescribed application form entitled "**Application Form for Admission of NRI/Children of NRI/Ward of NRI/OCI /Foreign National Candidate**" to be downloaded from the University Website <http://hillagric.ac.in>, specimen annexed as Annexure VI in the Information Brochure & Prospectus.

#### Note:

- a) *NRI candidates are such persons who do not reside in India and who are Non-Resident Indians (residing abroad). **NRI students** means wards of Indian citizen residing abroad and who have passed their qualifying examination i.e.*



12<sup>th</sup> standard which is equivalent to 10+2 Higher/Senior Secondary Examination or any other examinations equivalent thereto with requisite subjects from the School/College/University situated abroad.

- b) Ward of NRI is one who has no parents and has been taken as ward by other NRI relative. Such ward is considered for admission provided the guardian of ward is declared as guardian by the court as per provision in "The Guardian and Wards Act., 1890".
- c) OCI Cardholder shall have parity with NRI.
2. The admission under this category will be given only to NRIs and/or their children/wards/ OCI in **B.V. Sc. & A.H., B.Sc. (Hons.) Agriculture, M.Sc. Agriculture, M.V.Sc. and Ph.D. Agriculture programmes**. The academic eligibility requirements for these candidates are the same as for general category candidates. The candidate must send the application form complete in all respects along with a set of self-attested copies of the necessary documents and an application fee (*non-refundable*) of US \$ 500 (US\$ 520 in case of out station draft) in the form of a demand draft (*drawn in favour of Comptroller, CSKHPKV, Palampur (H.P.), India payable at any scheduled commercial bank at Palampur*) to the Registrar, CSKHPKV, Palampur (H.P.), India on or before the last date of receipt of application i.e. **04.09.2025 for B.V.Sc. & A.H., B.Sc. (Hons.) Agriculture, M.Sc. Agriculture, M.V.Sc. and Ph.D. Agriculture Programmes**. The application fee may also be deposited online in the Comptroller's Account No. **34854349548 (IFSC : SBIN 0003632) MICR : 176002063** and the **transaction number** thereof must be mentioned on the application form. In addition, NRIs/OCIs are also required to send the PDF version of application form along with relevant documents and proof of requisite fee through e-mail [registrar@hillagric.ac.in](mailto:registrar@hillagric.ac.in) to the Registrar, CSKHPKV, Palampur on or before the last date of receipt of application forms i.e. **04.09.2025**.
3. The NRI/OCI candidates seeking admission to **B.V. Sc. & A.H. B.Sc. (Hons.) Agriculture, M.Sc. Agriculture, M.V.Sc. and Ph.D. Agriculture programmes** of the University will be considered for admission strictly on the basis of their merit in the qualifying examination provided they fulfill the minimum eligibility qualification for the programme as given in the Information Brochure & Prospectus subject to verification of its equivalence. The detail of subjects studied, grades and percentage equivalent marks obtained is to be furnished in 13(a) & (b) of the Application Form. For admission to an Undergraduate programme, the syllabi of the courses studied at 10+1 and 10+2 level with a clear mention of web address of the concerned Educational Board/Institution must also be attached with the application. **Mere submission of application does not guarantee admission to the programme applied for.** In case, the number of applicants for **B.V. Sc. & A.H. and B.Sc. (Hons.) Agriculture** programmes is more than the number of seats available in the respective programme, the admission shall be made on the basis of *merit* in the qualifying examination. Similarly, in case of Masters' and Doctoral programmes if there are more than two candidates for a discipline, the admission shall be made to the said discipline on the basis of their *merit* in the qualifying examination.
4. The candidates seeking admission on the basis of NRI/OCI status are required to attach a photo copy of citizenship certificate and passport or any other valid document as per Annexure VII and Annexure VIII, duly attested by the Magistrate, with the application form.
5. The University shall notify the select and waiting lists of NRI/OCI candidates for **B.V. Sc. & A.H.; B.Sc. (Hons.) Agriculture, M.Sc. Agriculture, M.V.Sc. and Ph.D. Agriculture programmes** on the University Website <http://hillagric.ac.in>. The candidates from the select list shall be required to deposit the requisite fee as per university notification and must get registered themselves in person during the days of registration as given under Important Information. In case of failure to do so, the seat(s) shall be offered to the candidate(s) in waiting list. The candidates are advised to get in touch with the Dean concerned for any information about stay, commencement of classes, etc. and it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
6. The NRI candidates shall pay admission fee, tuition fee and hostel accommodation (non-refundable) charges as per Table at Sr. No. F of Chapter IV entitled "FEE STRUCTURE" in the form of demand draft in US \$ issued against the bank account of NRI in the country in which he/she is residing or in the shape of demand draft in equivalent Indian currency issued against his/her NRI account, maintained in India. **In the latter case, the candidate is required to submit a certificate from the bank that the draft has been issued against his/her parents'/guardian's NRI account.** The demand draft should be drawn in favour of the Comptroller, CSKHPKV, Palampur (H.P.), India payable at any scheduled bank at Palampur, India. However, the OCI card-holder can deposit the fee in the Comptroller's account FCRA A/C No. 34854349548 (IFSC : SBIN 0003632) MICR : 176002063 and proof thereof be submitted in the office of the concerned Dean at the time of registration.
7. The NRI/OCI candidates shall be required to have good proficiency in English language.
8. The NRI/OCI candidates may visit <http://hillagric.ac.in> for any information about admission, selection, etc.

## Rules and Regulations for Admission of Foreign National Candidates (Excluding those nominated/sponsored by GOI/ICAR)

The rules and regulations for admission of Foreign National candidates in the University will be as below:

1. The Foreign National candidates shall have to apply for admission for the programme of their choice on the prescribed application form entitled “**Application Form for Admission of NRI/Children of NRI/Ward of NRI/OCI/Foreign National Candidate**” to be downloaded from the University Website <http://hillagric.ac.in>, specimen annexed as Annexure VI in the Information Brochure & Prospectus.
2. The candidates must send the application form complete in all respects along with a set of self-attested copies of the necessary documents and an application fee (*non-refundable*) of US \$ 500 (US\$ 520 in case of out station draft) in the form of a demand draft {drawn in favour of Comptroller, CSKHPKV, Palampur (H.P.), India payable at any scheduled commercial bank at Palampur} to the Registrar, CSKHPKV, Palampur (H.P.), India on or before the last date of receipt of application i.e. **04.09.2025 for B.V. Sc. & A.H., B.Sc. (Hons.) Agriculture, M.Sc. Agriculture, M.V.Sc. and Ph.D. Agriculture programmes**. 5. The course-cum-registration fee and hostel accommodation (non-refundable) charges for foreign students shall be as per Table at Sr. No. F of Chapter IV entitled “Fee Structure”.
6. The University shall notify the select and waiting lists of Foreign National candidates for admission to **B.V. Sc. & A.H., B.Sc. (Hons.) Agriculture, M.Sc. Agriculture, M.V.Sc. and Ph.D. Agriculture** programmes on the University Website <http://hillagric.ac.in>. The candidates from the select list are required to deposit the requisite fee as per university notification and must get register themselves in person during the days of registration as given under Important Information. In case of failure to do so, the seat(s) shall be offered to the candidate(s) in waiting list. The candidates are advised to get in touch with the Dean concerned for any information about stay, commencement of classes, etc. and it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
7. Foreign National Candidates shall be required to have good proficiency in English language.
8. The foreign national candidates may visit <http://hillagric.ac.in> for any information about admission, selection etc.

**Note:** i. The admission of foreign national candidates nominated/sponsored by Govt. of India/ICAR shall be regulated by the Indian Council of Agricultural Research (ICAR), New Delhi.

ii. All foreign national candidates other than those sponsored/nominated by Govt. of India/ICAR shall have to apply for admission at CSKHPKV through Indian Embassy/High Commission in their respective countries of origin.

### Other documents required with the application form to be submitted by NRI/ OCI/Foreign National candidates:

- i. Documents as per Check List given in application form (Annexure VII)
- ii. Undertaking by NRI/OCI candidate’s parent/guardian (Annexure VIII)

### Note:

- i) The documents uploaded on the Digilocker will also be acceptable for document verification.
- ii) The Provisional Degree Certificate, Transcript of Academic Record, Degree, etc. to a student of CSKHPKV, Palampur will be issued by mentioning his/her name, Father’s Name and Mother’s Name as recorded in his/her Matriculation or equivalent certificate.

## INSTRUCTIONS/REGULATIONS REGARDING RAGGING

Ragging, in any form, is strictly banned and is a cognizable offence as per the directions of Hon'ble Supreme Court of India. If any incident of ragging comes to the notice of the authority, the authority would take stern action including expulsion from the Institution as per Chapter XVIII of Academic Regulations of CSKHPKV, Palampur. **At the time of admission and in the subsequent years every student shall be required to fill online Anti Ragging Undertaking at [www.amanmovement.org](http://www.amanmovement.org) (OR) [www.antiragging.in](http://www.antiragging.in) as per Annexure II.**

### Academic Regulation governing 'Ragging'

**[At par with the UGC Guidelines and Himachal Pradesh Educational Institutions (Prohibition of Ragging) Act, 2009]**

### *Preamble of Ragging*

18.2 Ragging includes any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indiscipline activities by any student or students which causes, or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof, in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing of power, authority or superiority by a student over any fresher or any other student, in the Institution. Therefore, to provide conducive and healthy environment for proper physical and psychological development of all students, the CSK Himachal Pradesh Krishi Vishvavidyalaya, in accordance with UGC Guidelines and the Himachal Pradesh Educational Institutions (Prohibition of Ragging) Act, 2009, brings forth these Academic Regulations to curb the menace of ragging (Applicable from July 4, 2009).

### Definition of Ragging

Any act or conduct of student/students whether by words spoken or written which has the effect of teasing, treating or handling with rudeness a fresher/freshers or rowdy or indiscipline activities which causes annoyance, hardship or psychological harm or to raise fear or apprehension thereof or asking to do any act which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of fresher/freshers or showing of power, authority or superiority on fresher/freshers.

Any act of violence, physical/mental, directed towards any other student of the College, within a Campus or outside a Campus is Ragging.

The act or conduct of ragging includes the following:

- i. any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- ii. indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- iii. asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- iv. any act by a senior student that prevents, disrupts or disturbs the regular academic activity of a fresher or any other student;
- v. exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students;
- vi. any act of financial extortion or forceful expenditure burden put on a fresher or any other student by student(s);
- vii. any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;

- viii. any act or abuse by spoken words, emails, SMS, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
- ix. any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing of power, authority or superiority by a student over any fresher or any other student;
- x. to force to look at pornographic pictures or to force take/ arrange drinks/intoxicants etc.

#### **Administrative Action in the event of Ragging:**

The institution shall punish a student found guilty of ragging after following the procedure as prescribed below:

- a) The Anti-Ragging Committee of the institution shall take an appropriate decision with regard to punishment or otherwise, depending on the facts of each incident of ragging, and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.
- b) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments:
  - i. cancellation of admission,
  - ii. suspension from attending classes,
  - iii. withholding/withdrawing scholarship/fellowship and other benefits,
  - iv. debarring from appearing in any test/examination or other evaluation process,
  - v. withholding results,
  - vi. debarring from representing the institution in any regional, national or international meet, tournament, and youth festival, etc.,
  - vii. suspension/expulsion from the hostel,
  - viii. expulsion from the institution and consequent debarring from admission to any other institution,
  - ix. fine of Rs. 25,000/-
  - x. collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

#### **Action to be taken by the Vice-Chancellor:**

On receipt of any information concerning any reported incident of ragging, the Vice-Chancellor shall immediately determine, if a case under the penal laws is made out, and if so, either on his own or through a member of the Anti-Ragging Committee authorized by him in this behalf, he would proceed to file a First Information Report (FIR) within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following:

- i. abetment to ragging;
- ii. criminal conspiracy to rag;
- iii. unlawful assembly and rioting while ragging;
- iv. public nuisance created during ragging;
- v. violation of decency and morals through ragging;
- vi. injury to body, causing hurt or grievous hurt;
- vii. wrongful restraint;
- viii. wrongful confinement;
- ix. use of criminal force;
- x. assault as well as sexual offences or unnatural offences;
- xi. extortion;
- xii. criminal trespass;
- xiii. offences against property;
- xiv. criminal intimidation;
- xv. attempts to commit any or all of the above mentioned offences against the victims;
- xvi. physical or psychological humiliation;
- xvii. all other offences contained in the definition of "Ragging".

Provided further that the institution shall also continue with its own enquiry initiated under this regulation and other measures without waiting for the action on the part of the police/local authorities and such remedial action

shall be initiated and completed immediately and in no case later than a period of seven days of the reported occurrence of the incident of ragging.

*“In case, FIR is lodged, on conviction, the student/students can be punished with imprisonment for a term which may extend to three years or with fine which may extend to fifty thousand rupees or with both”.*

***In compliance of the second amendment in UGC Regulations, it is compulsory for each student and every parent to submit an online undertaking every academic year at [www.antiragging.in](http://www.antiragging.in). To file an online anti-ragging affidavit, the student will receive an email with his/her registration number. The student will forward that email to the Students’ Welfare Officer-cum-Nodal Officer, Anti Ragging Cell email.***

## FEE STRUCTURE

The fee structure is approved by the Competent Authority of the University and it shall generally remain unchanged during the entire duration of the degree programme. The candidates selected for admission in the Undergraduate, Masters and Doctoral programmes shall have to pay **the requisite fee except hostel charges directly on the designated link on portal in the Comptroller's Account through internet banking or any other bank transaction on the day of counseling-cum-registration and admission -I/II on confirmation of admission to a seat in a programme, as case may be**, and submit the computer generated receipt or bank receipt as a proof of deposit of fee in the Office of the concerned Dean on the same day. The University will also provide the facility for the candidates to pay the fee on the spot. The candidate can also pay the fee by way of demand draft drawn in favour of Comptroller, CSKHPKV, Palampur payable at SBI, HPAU, Palampur (code 0003632), or payable at Palampur (in case of any other bank) and submit the said draft in the office of the concerned Dean on the same day of counseling-cum registration and admission -I/II, to the programme. On allotment of hostel accommodation to a student, he/she will have to pay the hostel charges **directly on the designated link on portal in the Students' Welfare Officer Account through internet banking or any other bank transaction and submit the computer generated receipt or bank receipt as a proof of deposit of fee in the Office of the Students' Welfare Officer**. The admission under Sports/Co-curricular activities sub category will be governed under CSKHPKV Academic Regulation 2.8.2 (iii) as per the criteria mentioned below:-

The minimum Academic Eligibility Criterion for consideration under sports category shall be 50% of the marks obtained by the Applicant in the NEET (UG)-2025/ CUET (UG)-2025 /ICAR AIEEA (PG)-2025 (applied to the respective programme of CSKHPKV). Once academically eligible, the merit of the candidate shall be determined solely in order of sequence first on the basis of his/her performance at the highest level and then participation at the highest level. The position obtained/participation made should not be earlier than five academic years preceding the year of admission. In case of the tie in the above, preference will be given to the candidate having scored higher as per the Table given below:
